On Wednesday at the ACEDS 2016 E-Discovery Conference and Exhibition, the organization awarded the second annual ACEDS Awards. The nominees were all pioneers and innovators in the e-discovery industry and are dedicated and committed to advancing the profession and remaining at the forefront of technology advancements, education, and training.

ACEDS presented the **Lifetime Achievement Award** to **Craig Ball**. Craig is an attorney and computer forensic examiner from Austin, Texas who often serves as a court-appointed special master in e-discovery disputes. But the thing that makes Craig essential to the e-discovery industry is not just that he is recognized as one of the best at his job, but that he has committed himself to educating and sharing his expertise in order to move our profession forward. He has delivered more than 1700 presentations and papers worldwide, most explaining how lawyers and litigation support specialists need not be afraid of data as evidence, but can

and should embrace it in serving clients.

The winner of the **CEDS Ambassador** award is **Robin Athlyn Thompson, CEDS**. Robin has over 40 years of experience in the industry managing discovery in high profile MDL litigation, and she's brought all of that experience with her as a member of the ACEDS Advisory Board and President of the ACEDS Phoenix Chapter. Additionally, as the Vice President of Marketing for BIA, she is a master networker and evangelist for the eDiscovery industry. Before ACEDS even existed, she was fighting to promote the visibility and stature of litigation support professionals and to create a standardized certification program that could help the industry.

Our **E-Discovery Person of the Year** is **Michael Quartararo, CEDS**. As director of litigation support in the New York office of the law firm Stroock & Stroock & Lavan LLP,

Mr. Quartararo has a long and distinguished career in the legal field in handling and managing complex e-discovery operations involving multiple parties and multiple lawyers. With Stroock since 2008, Mr. Quartararo was a co-founding member of the firm's E-Discovery and Information Governance Practice Group, leading a staff of project managers and technical analysts who provide consulting, litigation support, technology and training services to the firm's 300 attorneys and paralegals nationwide. Mr. Quartararo is also the author of the forthcoming book *Project Management in Electronic Discovery: An Introduction to Core Principles of Legal Project Management and Leadership in E-Discovery*, which is due to be published in the coming weeks.

In addition, Mary Mack, ACEDS Executive Director awarded three Executive Director's awards. The first went to **Bill Hamilton**, who was Quarles and Brady's first National E-Discovery Partner and now teaches Electronic Discovery and Digital Evidence as an adjunct professor at the University of Florida's Levin College of Law. Most importantly, Bill has been a full-throated advocate for certification and ACEDS since the organization's early days.

The second award went to the founder of the ACEDS Mentoring Program, **Leslie Saravia**. Her call for mentors and mentees was answered without hesitation and ACEDS thanked Leslie for her intuitiveness, volunteerism, and work in creating a world class foundation for this program.

The final Executive Director's award went to e-discovery service provider **Zylab**, whose good works include doing pro bono work on the UN War Crimes Tribunals, and whose support of ACEDS has never faltered. Many new ZyLAB people are certified now, and more are in the pipeline.
